Mission Statement

Saint Ann Catholic School is committed to proclaiming the Gospel message of Jesus Christ within a challenging academic environment. We are preparing to be knowledgeable, faithful, and responsible Christians who compassionately serve others.

Tuition rate for all students:

1 child = \$6,646.00 annual (10 mo. @ \$664.60 or 12 mo. @ \$553.83)
2 children = \$12,230.00 annual (10 mo. @ \$1,223.00 or 12 mo. @ \$1,019.16)
3(+) children = \$17,945.00 annual (10 mo. @ \$1,794.50 or 12 mo. @ \$1,495.42)
4% Discount for 1 Child = \$6,380.16 2 Children = \$11,740.80 3+ Children = \$17,227.20

Tuition Payment

Full payment of tuition on or before August 30, 2024 (Friday) will receive a four percent discount. Otherwise, tuition may be paid in ten equal monthly payments beginning August 1, 2024 (or twelve equal monthly payments beginning July 1, 2024). Payments are due the 1st of the month. A \$50.00 late fee will be applied if payment cannot be withdrawn from bank.

FACTS Billing

Payments will be deducted from your account based on the plan you choose. Incidental charges may occur throughout the year (athletics, drop-in EDP, library fee, scrip obligation, parent obligation and benefit raffle.) No payments will be made to the school office unless prior permission is granted. Payment selection will take place in the family portal during registration. By signing up for tuition AND incidental charges, this gives Saint Ann school permission to charge your account. An invoice will be sent the day of the charge and you are given 10 days before payment is deducted.

Annual Registration Fee (\$350.00 per student)

This non-refundable fee is used to pay costs directly related to the education of your child. This payment is due when you have officially registered online. **-NEW-** Families will be sent an email with registration instructions through FACTS Family Portal <https://stas-ca.client.renweb.com/pwr/>. *FACTS will deduct an additional \$11-returning student or \$22-new student for submission fees.*

Student Fees (\$25.00 per student)

There will be a \$25.00 charge (per child) for a student fee. This fee will go towards supplies for the Holiday Bazaar and Benefit Raffle Dinner.

Tuition Assistance (Diocesan & In-House)

The Diocese of Fresno provides tuition assistance to the neediest families regardless of their religious denomination. Saint Ann school also offers in-house tuition assistance, but funds are limited. In order to apply for tuition assistance, you must first use the FACTS Tuition Mgt. & Financial Aid Service. **Go to <https://online.factsmtg.com/aid> for filing online; the cost is \$24.00 and families have until April 15th to apply.** The family portal also has a link you can use to apply. After you have submitted your application to FACTS, the office will call you to schedule an appointment with the principal to further discuss your tuition assistance needs. No appointments will be scheduled unless the FACT application has been completed.

Parent Participation Hours – 30 hours per year (2-Parent Family); 15 hours per year (1-Parent Family)

Every week there are suggestions for earning parent hours in the school and teachers' newsletters. An assessment of \$30.00 per hour (for each hour that a family is below their 30-hour / 15-hour obligation) will be applied towards family account at the end of the school year. 50 % of your family hours must be through fundraising activities. Donating hours is prohibited. The deadline to earn parent hours is May 1, 2025.

Scrip: Each family has an obligation to raise \$400 through the scrip program. With scrip, you earn rebates on money that you are already spending. Do you spend money at Stater, Walmart, Home Depot or Amazon? Buy gift cards through scrip for those purchases, and earn a portion of that back. After you reached the \$400 obligation, any additional rebates you earn will benefit you in the way you choose (tuition, registration, etc.) The deadline to meet scrip obligation is March 31, 2025.

Example of how scrip cards work: You purchase an Albertsons card for \$100.00 from the school and earn \$4.00 towards your \$400 obligation. The amount of scrip credit you earn is determined by the rebate each company gives to the school (Walmart is 2.5%, Pizza Factory is 20%, etc.).

Benefit Dinner Raffle Ticket (\$275.00 Each)

All families are obligated to purchase or sell one raffle ticket prior to one week before the benefit date in February 2025. Those families wishing to sell, rather than purchase, may sign up to sell after masses. If a family does not sell or buy their ticket, \$275.00 will applied to your account even if tickets are sold out.

Absences/Tardies

Consistent and prompt attendance is crucial to school success, classroom efficiency, and self-esteem. Excessive tardiness or absences will result in a parent conference with the teacher and/or principal. Persistent tardiness or absence may, at the discretion of the principal, result in decreased academic credit or disciplinary action including dismissal from school.

Uniforms

It is the intent of Saint Ann School to maintain a neat and well-groomed appearance throughout the student body. The following information is the required uniforms for both levels.

Elementary-Red polo shirts (logo) with Dennis Uniform bottoms or Mc Donald plaid bottoms

Middle School-Black polo shirts (logo) with Dennis Uniform bottoms or Mc Donald plaid bottoms

Extended Day Care

Extended Day Care is an afterschool program that offers academic assistance, enrichment activities and a safe, outdoor supervised environment that begins at the end of the school day to 6:00 PM
